

## PARISH BOUNDARIES

### ST. MARK – Lemay

Starting at the St. Louis city limits and the Mississippi River;  
South along the Mississippi River to the eastern extension of Ripa Avenue;  
West along the eastern extension of Ripa Avenue and Ripa Avenue (north side) to South Broadway  
North on South Broadway (east side) to West Arlee Avenue;  
West of West Arlee Avenue (north side) to Clyde Avenue;  
North on Clyde Avenue (east side) to Loretta Avenue;  
West on Loretta Avenue (north side) to Telegraph Road;  
North on Telegraph Road (east side) to Lemay Ferry Road;  
South on Lemay Ferry Road (west side) to Mount Olive Road;  
West on Mount Olive Road (north side) and its extension to the Gravois Creek;  
South on Gravois Creek to Green Park Road;  
East on Green Park Road (south side) to Lemay Ferry Road;  
Southwest on Lemay Ferry Road (north side) to the drainage ditch;  
East along the drainage ditch to Jeffersonian Drive;  
East on Jeffersonian Drive (both sides) to Telegraph Road;  
North on Telegraph Road (east side) to Kingston Drive;  
North on Kingston Drive (east side) to South Broadway;  
South on South Broadway to the northern gate of Jefferson Barracks (at Teddy Avenue);  
East along the northern Boundary of Jefferson Barracks to the Mississippi River;  
South along the Mississippi River to Interstate 255;  
West along Interstate 255 and continuing on Lindbergh Boulevard to Lemay Ferry Road;  
South on Lemay Ferry Road (west side) to Forder Road;  
West on Forder Road (north side) and its extension to the Frisco Railroad tracks;  
North along the railroad tracks to its intersection with Grants Trail to the nearest point at Mackenzie Road;  
North on Mackenzie Road (east side) to Koerber Lane;  
East on Koerber Lane (south side) and along an imaginary line north of Southview Lane and south of Radio Drive to the end of Radio Drive;  
West and north on an imaginary line that is west of Dana Avenue, south of Anchor Drive, west of Port Drive and west of Zane Drive to the intersection of Arvin Place and Meister Lane;  
East on Arvin Place (south side) to Dana Avenue;  
North on Dana Avenue (neither side) to the southern boundary of Wilbur Park just north of Moccasin Terrace;  
East on the southern boundary of Wilbur Park and its extension along an imaginary line south of Bayless High School and north of Canoe Drive to the western end of Schmittwoods Court;  
East on Schmittwoods Court (neither side) to Kammerer Avenue;  
North on Kammerer Avenue (east side) and extended to Kammerer Avenue (east side) to the St. Louis City limits.  
Southeast along the St. Louis City limits to the Mississippi River.
